Updates

- The Detective Division investigated multiple armed robberies.
- The Detective Division investigated several non-fatal shootings.
- On May 20th, the Detective Division investigated a homicide at 8700 Devonshire Street. On June 28th, detectives charged Gregory Thomas, 36, of Thornton with the murder.
- On June 11th, the Detective Division investigated a homicide at the Primrose Motel and subsequently obtained an arrest warrant for the suspect. On June 17th, patrol located and arrested the suspect, Tomas Perez-Gonzalez, 33, of Denver after a brief standoff.
- **Recognition**
 - Dep. Gregory Blevins developed an Internet Crimes Against Children Case that resulted in the execution of a search warrant at 8923 Princeton Street. A search of the residence and electronics revealed over 1,000 images of children depicting torture and rape. The suspect was charged by the 17th Judicial District and will also be charged Federally. Dep. Blevins should be commended for his hard work and dedication.
 - The ACSO Victim Advocates covered an enormous caseload in June while working with a “skeleton crew” of staff. The VA squad should be commended for their work ethic.

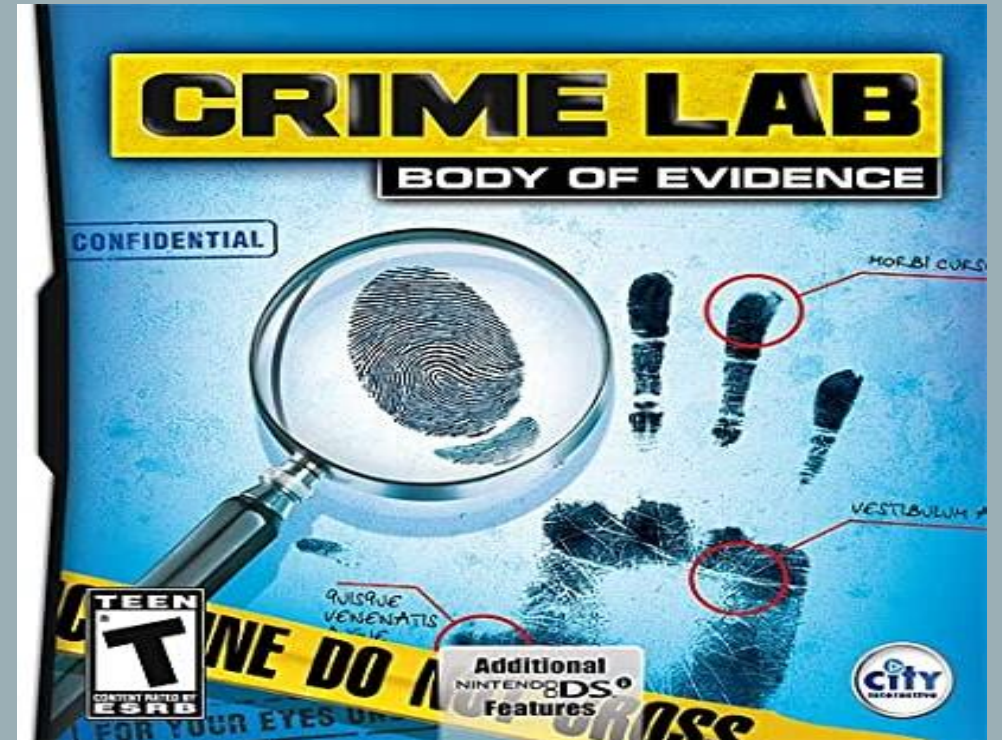
