Our work with community relations has been at the forefront during my time as Sheriff. The Adams County Sheriff's Office Community Connections Team was formed with the goal of using many different platforms to connect our Agency with the community. The team is a diverse group made up of civilian and certified staff. The five-person team plans and supports events hosted by the Sheriff's Office, releases public information through social media, the Sheriff's App, radio, television, our website, and other platforms. With a fast growing county like ours, I feel this team is necessary to help keep our community informed in a timely manner.

2017 was a very important year for the Adams County Jail Division. Construction finished at the end of 2017 and we celebrated the opening of our new Mental Health Unit in December. The Sheriff's Office is seeing more and more inmates come through our facility with mental health needs. This Unit provides a separate living space for inmates who have behavioral problems related to mental health.

As we look to the future, FLATROCK Regional Training Center is expanding. Recently, construction was completed for our new Physical Ability Course. By the end of 2018, FLATROCK will have an inflatable wall training venue to use for building search training. This is just the start of more great things to come.

Each day I remind myself of the great opportunity I have to work alongside the brave men and women with whom I serve. As an Agency we will continue to listen to our community and serve you to our highest potential. I am grateful to serve as Sheriff of the finest and most professional law enforcement agency in the country, the Adams County Sheriff's Office.

PATROL DIVISION



The Adams County Patrol Division provides law enforcement services, community policing, and traffic safety to the communities of unincorporated Adams County. In 2017, the Patrol Division was made up of 123 employees. These men and women are our boots on the ground, meeting you face to face in good times and helping you to navigate through difficult times.

DID YOU KNOW

- The Patrol Division had 222 citizens participate in the ride along program in 2017.
- Our deputies responded to 46,951 citizen calls and had an additional 63,410 officer initiated activities.
- In 2017, 'StarChase' systems were implemented to help track stolen vehicles.

MOBILE COMMAND POST



In 2017, the Adams County Sheriff's office received our Mobile Command Post from Brighton Fire who obtained it in 2005 on the Urban Area Security Initiative grant. The Command Post is deployed for major crime scenes or other incidents which require on scene command staff. It is also utilized for special events. In the future, the Command Post will be upgraded with new equipment which will allow for on scene dispatching or other communication needs during a major disaster or event. This will allow real time information to be transmitted to command staff not on scene as well as the Emergency Operation Center.

SPECIAL UNITS

S.W.A.T.

The Adams County Sheriff's Office Special Weapons and Tactics Team (SWAT) was founded in 1985. SWAT is made up of one Commander, Assistant Commander, 20 Tactical Operators, two Precision Rifles Operators, one Medic, and eight Crisis Negotiators. SWAT is a special unit. This unit is a secondary assignment for deputies. SWAT goes through a great amount of training with 20 hours per month and 40 hours of SWAT week training annually. SWAT averages between 20 and 30 operations per year. SWAT members are on call 24/7/365. Some of the calls could range from an active shooter to a high-risk warrant. At the Adams County Sheriff's Office, deputies need to have two years of experience on patrol to even be considered to go through the testing process to become a SWAT member.

BOMB SQUAD

The Adams County Bomb Squad is made up of six team members. Five of the members are certified bomb techs and one is a para-tech. The Bomb Squad is a secondary assignment with each member having another primary assigned duty. The Bomb Squad is responsible for responding to all calls of suspicious devices in Adams County, Broomfield County, and other jurisdictions when requested. The Bomb Squad performs and assists surrounding agencies with the disposal of hazardous materials.

- Provide explosive breaching entry for S.W.A.T. teams around the area.
- Provide remote recon for jurisdictions in the area.
- Search for booby traps.
- Attend community events.
- Educate law enforcement and the public on explosives.

In 2017, the Bomb Squad purchased its new Bomb Truck as well as an EOD 1-Bomb Suit. These were both purchased by Adams County. Federal grants were used to purchase a Power Hawk system as well as a portable X-Ray system.



K9 UNIT

The Adams County Sheriff's Office K9 Unit is made up of nine Teams: two in our jail and seven in patrol. All K9 Teams are multi-purpose, performing drug or explosive searches, building searches, and tracking. Recently, the K9 Unit received ballistic vests which were donated from different organizations. These vests cost \$700 per K9 and offer similar protection to that of an officer.


DID YOU KNOW

The Adams County Sheriff's Office K9 Unit was established in 1981. The K9 Unit started with a single K9 Team. The original K9 Team was not originally funded by the Sheriff's Office. Deputy Jeff Johnson paid for all his equipment and training out of pocket and was not paid for his training time.

TRAFFIC UNIT

The Adams County Sheriff's Office Traffic Unit's primary goal is to make the streets of Adams County safer through a proactive systematic approach to enforcement. The Traffic Unit specializes in speed enforcement, school zone enforcement, commercial vehicle enforcement, and DUI enforcement.

The Traffic Unit is made up of eight officers: four officers in unmarked vehicles and four on motorcycles. In 2017, the Adams County Sheriff's Office assigned two deputies to commercial vehicle inspections.

The Traffic Unit participates in two to three checkpoints a year. They are also involved in 14 high visibility enforcement periods that are organized by the Colorado Department of Transportation.



The Adams County Sheriff's Office Motorcycle Unit is made up of four BMW motorcycles. All of our motorcycle deputies are DUI certified.



COMMUNITY RESOURCE TEAM

Objective of CRT is to identify high crime areas within Adams County and impact those areas by proactive policing, building on the partnership with county government, and through trust and partnership with the community. Goals of CRT are to reduce crime and the fear of crime, ensure citizens that we will legally go above and beyond our abilities to rid their neighborhoods of crime, and improve their quality of life.

BIKE UNIT



The Bike Unit is utilized to increase the visibility of the Sheriff's Office. They are able to get through traffic and crowds quickly and efficiently. They patrol the trail system and schools.



JOINT TERRORISM TASK FORCE

Since October 2017, the Adams County Sheriff's Office has had a full time deputy assigned to the Denver Joint Terrorism Task Force (JTTF). The JTTF mission is to enhance communications, coordination, and cooperation between federal, state, and local government agencies and act as a focal point for terrorism intelligence and investigations. With over 4,000 Task Force Officers (TFO) assigned nationally to the JTTF in a number of different capacities, the FBI and participating agencies provide a multitude of resources to detect, disrupt, and dismantle terrorist activity. JTTF TFO's provide geographic and socio/economic expertise to act as a window into the community to ensure the safety of its citizens.



Two deputies are assigned to the Adams County homeless situation. They investigate homeless complaints and work closely with county government officials to find solutions.

JUVENILE SERVICES UNIT

The main purpose of the Juvenile Services Unit (JSU) is school safety and security. School Resource Officer's (SRO's) offer services to 41 Adams County schools. SRO's teach several classes to students such as U.S. Government and Drug Safety. SRO's are continually training throughout the year. They attend monthly Patrol training and usually attend an annual SRO conference to obtain specialized training for schools.



MOBILE FIELD FORCE TEAM

The primary role of the Mobile Field Force Team (MFFT) is to respond to civil disorder incidents. While Adams County doesn't have many large disturbances, the MFFT has made their team available regionally to supplement neighboring agencies in the event that a large scale event were to occur within their jurisdictions. The MFFT also assists the Patrol and Detective Divisions with incidents requiring a large manpower need, such as long term scene security and large area searches. MFFT is a special unit. This unit is a secondary assignment for deputies.



The Mobile Field Force Team consists of two commanders, four sergeants and 30 deputies. This year to date MFFT has been called out nine times and logged a total of 311.5 hours.



PLAINS SECTION

The Adams County Sheriff's Office Plains Section home office is located in Strasburg. The team is comprised of a Commander, two Sergeants, eight Patrol Deputies, one School Resource Officer, and one Detective. All team members are considered "resident deputies" who work and reside within District 5 boundaries.

DID YOU KNOW

Plains Section duties are comprised by the following boundaries: Watkins Road to the west; Meridian Mile Road to the east; 168th Ave. to the north; and 15th Ave to the south. In all, the team is responsible for close to 1,100 square miles. On top of their own district boundaries, the team routinely provides cover for the Arapahoe County Sheriff's Office (over 700 square miles) and the Colorado State Patrol. Because of the continued residential and commercial growth in Bennett, the deputies had a 10% increase in calls for service compared to 2016. (22% increase for the entire district). The town of Bennett has predicted an eight year increase of the current population, 2500 residents to 11,000. Plans are already underway to add additional deputies to the District 5 team.

CHAPLAINS

The Adams County Sheriff's Office Chaplaincy exists to provide counseling, emotional support or spiritual guidance for members of the Office, their families, and members of the public.

In 2010, Pastor Brian Thompson started volunteering with the Adams County Sheriff's Office (ACSO) Academy cadets as a Chaplain. Teaching Emotional Survival for Law Enforcement to Academy Cadets and their families remain a primary activity of Chaplain Thompson. Over time, it became evident that the academy staff was receiving more benefit than the cadets themselves. Therefore, in about 2012, Captain McIntosh (now Sheriff McIntosh) invited Pastor Thompson to become the Chaplain of the organization, offering invocations at major functions and being available to assist employees sworn and civilian as needed. In 2014, Pastor Thompson challenged the POST certification successfully and became a sworn ACSO Reserve Deputy. In 2015, Pastor Thompson became the Lead Chaplain and a part time Deputy of the ACSO. He now trains with sworn employees and assists deputies on Patrol while being available to all employees of the ACSO, sworn and civilian.



There are currently two Chaplains at the ACSO: Lead Chaplain Brian Thompson, Senior Pastor of Purpose Church in Firestone, and Chaplain Joel Kershaw, Senior Pastor of Brighton United Methodist Church.

The Jail Division is responsible for providing a safe and humane environment for those incarcerated at the Adams County Jail. Our jail personnel manage the movement, behavior, and transportation of inmates. In 2017, the Jail Division was made up of 314 employees. More than half of our employees work within our Detention Facility, Civil Section, or Court Security.

BOOKING

In 2017, Deputies at our Jail booked in 19,864 inmates, which is an increase from the previous year, where 18,487 inmates were booked into the Adams County Jail. Deputies assigned to the Booking Unit within our jail are responsible for processing and filing paperwork that accompanies the arrest or release of an arrestee in the Adams County Jail. In our Booking Unit, our deputies and staff saw an increase in both felonies and misdemeanors from 2016 to 2017.

COURT SECURITY AND TRANSPORT




Court Security serves 31 courtrooms at the Adams County Justice Center in the 17th Judicial District. Our Court Security Deputies are responsible for not just the movement of adult offenders to and from court and our jail, but all juveniles in this jurisdiction, and sometimes other jurisdictions.



The Transport Unit completed 7,477 transports of adults in 2017, 353 more than the previous year.

INMATE PROGRAMS

Inmates within the Adams County Jail can participate in our Law Library, Religious, and Educational programs while they are incarcerated. In 2017, there were more than 19,000 hours that inmates spent in our Religious Programs. Inmates also used the Law Library, with more than 6,000 hours in attendance and the Education program, which showed more than 5,800 hours in attendance.



These programs are also a way to give inmates other opportunities once they leave our facility and hopefully decrease their recidivism rate.

WORK RELEASE PROGRAMS

Court Services is responsible for our Work Release Programs which allows inmates to keep their jobs while serving their jail sentence. Inmates go to work from jail and then return to jail after work. A judge must award the inmate with the possibility to work while serving their sentence. There are also certain requirements employers must follow as well.




Detention Facility

Inmates can apply for the work release program while in our detention facility. In 2017, more than 420 inmates conducted a work release interview and 274 applications were accepted.

CIVIL SECTION

The Civil Section is responsible for the services of all civil papers received by the Adams County Sheriff's Office. Our Civil Deputies not only serve in unincorporated Adams County, but also our cities within the county. The Adams County Civil Section consists of one Sergeant and five Deputies. Evictions are a high priority for this section.

The Civil Section executes all court orders involving civil process issued by the Courts, to include the collection of money and/or seizure of property.

JAIL SPECIAL OPERATIONS GROUP

The Jail Special Operations Group (JSOG) is a specially equipped and trained team designated to respond to situations in our Jail that may require additional elements. These elements may include additional manpower, equipment, skills, or teamwork and capabilities outside the regular resources and training of the average line detentions deputy. The JSOG Unit is comprised of 15 people including one team Commander, three Team Leaders, and 11 highly trained members. JSOG is a special unit. This unit is a secondary assignment for deputies.


- Includes firearms, less lethal impact munitions, flash and sound diversionary devices and chemical munitions
- These tools are combined with specialized tactics designed to control force in a scaled, articulable manner.

MENTAL HEALTH UNIT

In December 2017, we added a Mental Health Unit to our jail dedicated to treating those with mental illness. The Mental Health Unit provides separate living quarters and treatment areas for inmates who have behavioral problems related to mental illness.

The Community Reach Center (CRC) has been an integral part in this process. Staff from CRC are stationed at our Detention Facility to assist inmates in the Mental Health Unit. The unit enables these specialists from CRC to coordinate continuity of care upon release.

The goal is to help these individuals stay out of jail after they are released.



Additional funds were used to staff 10 deputies and two certified nursing assistants with specialized training in mental health treatment.

VIVITROL PROGRAM

- In 2018, the Adams County Sheriff's Office initiated a new opioid treatment program at our Detention Facility.
- The Adams County Sheriff's Office, Correct Care Solutions, Community Reach Center, and Alkermes have partnered together to provide VIVITROL to eligible inmates who have detoxed from opioids.
- VIVITROL is a once-monthly medication for the prevention of relapse to opioid dependence.
- This initiative along with the opening of our Mental Health Unit in December 2017 continues to be a model for a new era of custody and treatment of inmates in our Detention Facility.



JAIL RECORDS TECHNICIANS

Jail Record Technicians are non-certified members that work at the Adams County Jail. Record Techs provide support by maintaining records, warrant entries, and inmate booking information for the Adams County Jail. Our Jail Record Technicians also assist the public with inquiries on the status of records, collection of fines, bail fees, and general information as it relates to inmates within our Jail.



Our Record Techs fully staff the Detention Facility 24 hours a day, 7 days a week.



DETENTION SPECIALIST


Detention Specialists is another civilian position at the Adams County Sheriff's Office.

Our Detention Specialists are located at our jail and perform specialized law enforcement work on an assigned shift in the care and security of inmates in an assigned area.

They also monitor security, inmate/detainee movement and operate computer and surveillance monitors.



Our Detention Specialists and Jail Deputies work well together to make sure they are keeping themselves and the inmates safe.



Many of our Detention Specialist end up testing for our Academy after a few years on the job.

JAIL POPULATION MANAGER



The Jail Population Manager is a new position and was added in 2018. The role of the Jail Population Manager is to help maintain the inmate population of the Adams County Jail below the functional capacity of the facility.

The Jail Population Manager identifies inmates who are suitable for transfer or release and monitors emerging trends in the jail population.

BAILIFF PROGRAM

In 2018, our Agency also added a Bailiff Program to our Jail Division. The Court Bailiff position is a part-time position, performing general courtroom duties and provide security during municipal inmate advisals in the jail.



DID YOU KNOW:

- You have to have previous law enforcement or corrections experience for the position.
- Many of our retired deputies have applied for this program.
- Jail staff hopes having the Bailiff Program will assist deputies in the jail with their day-to-day duties.



DETECTIVE DIVISION

The Adams County Sheriff's Office Detective Division investigates, apprehends, and prepares case files for prosecution of criminal offenders for the Adams County Sheriff's Office. In 2017, 5,733 cases were assigned to our Detective Division.



In 2017, Detectives received 23,757 items for property and evidence collection. Detectives disposed of 15,672 items.




PROFESSIONAL STANDARDS

FLATROCK REGIONAL TRAINING CENTER

The Professional Standards Division is responsible for monitoring and implementing training in all divisions of the Adams County Sheriff's Office. The Professional Standards Division is also responsible for all P.O.S.T. Academy training and overseeing policy and procedure.

ADAMS COUNTY SHERIFF'S ACADEMY



In 2017, the Professional Standards Division was responsible for a total of 116,234 hours of training.

- FLATROCK Regional Training Center hosts the Adams County Sheriff's Academy each year. Two full-time academies resulted in a total of 85,995 hours of training.

- Beginning in 2019, FLATROCK Regional Training Center will host three academies a year.

- During the course of each academy, instructors teach a multitude of skills and tactics.



EXPANSION PLANS



- In 2017, FLATROCK added a new building for classroom and defensive tactic use.

- FLATROCK has added a Physical Ability Course on site.

- FLATROCK is adding a 2-acre facility to practice scenarios involving public transportation along with two buses and a light rail train to practice safely contacting citizens and dealing with emergency situations.

ACADEMY CLASS 23



OFFICE OF THE SHERIFF



The purpose of the Office of the Sheriff is to reinforce and support the Sheriff's Office mission by providing professional services and interacting with the community in a positive manner. The core services that fall under the Office of the Sheriff include: Internal Affairs, Community Connections Team, Human Resources, and Concealed Handgun Permits.

CONCEALED HANDGUN PERMITS



CHP is on track to issue over 4,000 new and renewal permits in 2018.

Our CHP Unit issues the Concealed Handgun Permits for Adams County Residents. We currently have four full-time civilian employees who issue permits.

By state statute the County Sheriffs are required to issue Concealed Handgun Permits (CHP) in Colorado for the residents of their county. Our unit is dedicated to handling the intake of new applicants, as well as issuing the renewal of existing applicants every 5 years.

NEW applicants are fingerprinted, photographed and their application and training certificate are reviewed for completeness. They then send the fingerprints to Colorado Bureau of Investigations (CBI) Once the fingerprint background is finished they send CHP what is called an Insta-check, stating if the applicant is eligible or not to possess a firearm. We then complete our portion of the background and determine if that applicant can conceal a firearm. If they can, we issue a Concealed Handgun Permit (CHP), which is good for 5 years.

RENEWAL applications are handled almost the same, but we do not have to send in new fingerprints. Since our Agency went to an appointment system online they are able to run a portion of our background prior to the applicant's arrival and if we find them still in good standing we issue the renewal card on the spot.

HUMAN RESOURCES

Our Human Resources (HR) Section provides support to the agency with employee relations, employee law, policy interpretation, compensation, recruitment, background investigations, time-keeping, benefits, and leave administration. The HR Section consists of a manager, multiple HR Specialists, an Administrative Technician and three background Detectives.

In 2017, the Human Resources Section rebranded their Unity College program for our managers and supervisors within the Adams County Sheriff's Office. The Unity College allows managers and supervisors within the agency to go through a number of classes that will help them in their new rolls. Last year, we had 39 employees who participated.

FUTURE PLANS:

Our HR Staff has some plans for the future, including Employee Referral Signing Bonuses, a Recruitment Team and Field Training Officers Compensation.



INTERNAL AFFAIRS

Our Internal Affairs (IA) is responsible for investigating complaints or allegations involving Adams County Sheriff's Office personnel. The complaints are either initiated internally or by someone outside of the Sheriff's Office. At the Adams County Sheriff's Office, Internal Affairs consists of one Commander and two Sergeants.

DID YOU KNOW:

From 2015 to August 2018 we have had 89 IA's come from the Jail Division and 92 come from the Patrol Division, which totals to 184 total cases. Of those cases, 51 took over 180 days to complete. On average Internal Affairs tries to get cases complete within 45 to 60 days.

COMMUNITY CONNECTIONS TEAM

Our Community Connections Team (CCT) was established by Sheriff Michael McIntosh to better connect with the community and the residents we serve. The Community Connections Team consists of a Sergeant, who is also the Public Information Officer (PIO) and works with local media. Also on the team are two Senior Deputies who assist with PIO duties, partner with the community to plan events, put together town hall meetings, and teach community policing/crime prevention. Lastly, we have two Communication Specialists who assist with all marketing materials, social media, videography/photography, Facebook Live and our Annual Report.




ADMINISTRATIVE SERVICES



The Administrative Services Division provides administrative support and expertise in the areas of Finance, Records, Information Technology, and Office of Emergency Management to the other areas of the Sheriff's Office.

FINANCE

The Finance Office performs many different functions for the Sheriff's Office which include developing and managing the budget, purchasing supplies and equipment, issuing requests for proposals, developing contracts with vendors, processing incoming and outgoing funds, issuing and tracking uniforms and equipment, and accounting for the Detention Facility. For 2018 the Sheriff's Office Budget is \$79,028,523 and that budget is split between 7 different divisions.



To offset the \$79M expenditures, ACSO will collect \$7.8M in revenues in 2018:

**- Revenues from Grants/Local Gov.
\$1,397,159**

**- Charges for services (CHP, Academy)
\$5,115,329**

**- Fines and Forfeitures
\$1,258,080**

DID YOU KNOW:

- The Jail Accounting Office is responsible for processing inmate money received from booking, bonding, transport, releasing, work release, mail, and the cash intake kiosk. Annually, the Accounting Office processes close to \$3.8M.

- One major project completed in 2018 was purchasing and issuing 115 new higher safety rating ballistic vests to the entire patrol division.

INFORMATION TECHNOLOGY

Our Information Technology section is a team of eight personnel who supports over 670 users ranging from employees to contractors, temps, and cadets across six physical locations.

In 2017, 130 new Mobile Data Computers (MDC) were deployed to all Patrol and Civil deputies in an effort to improve service while reducing long term replacement costs.

In 2018:

- The IT Section was instrumental in setting up the environment necessary to facilitate court advisals via video conference for municipal inmates.
- Additionally, they assisted with the technical preparation necessary for the opening of the jail Mental Health Unit.
- By mid-year, the team was able to prepare for a large Academy out at FLATROCK by supplying enough laptops, and preparing server and WiFi resources necessary to support 80 cadets.
- This year, the IT Section also welcomed a new staff member for the Application Programmer/Analyst III position, filling a critical gap in coverage for database administration and software development.

ADMINISTRATIVE SERVICES RECORDS SECTION



Our Administrative Services Records section is comprised of four units: Records, National Incident Based Reporting System, Warrants, and Extraditions. Each unit has been extremely busy with their everyday responsibilities in addition to learning and preparing for a lot of new systems and procedures that were applied in 2017.

NEW Records Management System

The new system allows our staff and deputies a more effective method to perform their jobs.

- The Sheriff's Office adopted a new Records Retention Schedule last year.

- In 2017, we began coverage for three of our municipalities from 10:00 pm to 6:00 am.

- By providing this service it has allowed Brighton, Commerce City and Northglenn Police Departments the opportunity to shut down there civilian operations at night.

OFFICE OF EMERGENCY MANAGEMENT

The Adams County Office of Emergency Management (OEM) provides emergency management services to the residents and businesses within Adams County. OEM works in coordination with state and local partners to reduce the impact of all natural, technological, terrorism, and intentional risks. OEM provides services across all phases of the emergency management lifecycle from preparedness, mitigation, and prevention.



OEM participated in 19 events/presentations, which include presentations at the Colorado Emergency Management Conference, Emergency Preparedness Class for the Administrative Services Staff, Adams County Fair, National Night Out, and Operation Freebird.


In 2018 the Adams County OEM responded or activated monitoring for:

- Deputy Gumm Incident Management Team
- Deployed to the State Emergency Operations Center Logistics Section for the Spring Fire
- Seven fire events to include wild land and structure fires
- 43 hazardous materials events / spill reports
- 20+ severe weather monitoring activations (winter weather, red flag, and severe storms)

2018 Stats:

1. Participated in 16 Regional/State exercises to better respond to potential incidents.
2. Searches for lost/missing individuals and 56 special event support.
