Arrest in home invasion robbery

Adams County, Colo. (March 20, 2020):

The Adams County Sheriff's Office is investigating a home invasion robbery that occurred in the 8700 block of Oakwood Street.

On March 19th, 2020 at approximately 11:23 p.m., deputies responded to a residence in the 8700 block of Oakwood Street on a report of a burglary in progress. Upon arrival, deputies encountered three victims outside the residence and observed an Acura SUV speeding away from the residence. Deputies pursued the suspect vehicle which eventually was blocked by a train at 80th Avenue and Stuart Place. The suspect vehicle then traveled south, lost control, and struck a parked vehicle in the 4300 block of 78th Avenue. Three suspects exited and ran from the vehicle, throwing items of evidence, including a handgun. Two of the suspects were located hiding under a vehicle in the area. A third suspect was tracked by ACSO K-9 Colt, to a residence in the 7700 block of Stuart Street. The suspect had entered the residence without permission and was found hiding in an unfinished room in the house.

An investigation by ACSO detectives revealed the suspects had approached the residence, knocked on the door and requested to borrow a snow shovel. Once the door was open, the suspects forced their way into the residence armed with guns and demanded money. The suspects ransacked the house and fled with an undisclosed amount of currency. The suspects were arrested and charged with the following:

Soloman Assowa Yonis, AKA, "Little M", 32, of Denver:

- Kidnapping 1st degree (force), a class 2 felony
- Burglary 1st degree (armed), a class 3 felony
- Aggravated Robbery (residence/gun), a class 3 felony
- Criminal Trespass 1st degree (dwelling), a class 5 felony

Donjure Walker, AKA, "Don", 31, of Denver:

- Burglary 1st degree (armed), a class 3 felony
- Aggravated Robbery (residence/gun), a class 3 felony

- Vehicular Eluding, a class 5 felony

Antwyon Martell Pierce, AKA, "Twon", 30, of Denver:

- Burglary 1st degree (armed), a class 3 felony
- Aggravated Robbery (residence/gun), a class 3 felony
- Possession of a Weapon by a Previous Offender, a class 6 felony

The suspects are held in the Adams County Detention Facility pending further court proceedings.

The Adams County Sheriff's Office or North Metro Drug Task Force has determined that there is probable cause to make an arrest. The defendant(s) are presumed innocent until convicted in court. The 17th Judicial District (District Attorney) may decline to prosecute or refuse to file charges in this proceeding. Consequently, charges are often reduced, dropped or dismissed.
