Arrests made after Shooting

Adams County, Colo. (February 16, 2021):

The Adams County Sheriff's Office report the arrest of two persons subsequent to a shooting investigation.

On February 10th, 2021, at approximately 11:35 p.m., deputies responded to the area of I-76 and Tennyson St. in regard to a shooting that occurred on the highway. The victim was traveling east on I-76 when a dark sedan approached her vehicle. The front seat passenger pointed a large frame semi-automatic handgun at the victim's vehicle and fired multiple rounds. The bullets shattered the glass and penetrated the vehicle in several locations.

The ACSO Laboratory and Crime Scene Team responded to the location to process the scene. Detectives conducted a preliminary investigation and determined that the suspects were known to the victim. The suspects were identified as Alexis Mary Fernandez and Isaiah Cain Trujillo-Tucson. Detectives developed additional information about the suspects through social media and Trujillo-Tucson's supervised release status.

On February 12th, 2021, detectives tracked the suspects to an apartment complex 10500 block of Dover Street in Westminster. Detectives subsequently located Trujillo-Tucson in a black Volkswagen sedan in the area of Church Ranch Road and Wadsworth Boulevard. Deputies successfully deployed "stop sticks" to disable the suspect vehicle. The suspect vehicle continued to flee into the apartment complex. The suspect exited the vehicle as it was in motion and fled on foot. Trujillo-Tucso was captured by ACSO Detectives and members of the ACSO SET (Special Enforcement Team).

Detectives subsequently recovered several handguns and a modified AR-15 style rifle after Fernandez attempted to dispose of the evidence.

The following charges have been submitted for filing:

ISAIAH CAIN TRUJILLO-TUCSON, AKA: "SCUUBA", 22, of Westminster, a member of the BLOODS criminal street gang

- · Attempted Murder 1st degree, a class 2 felony
- · Menacing (Aggravated-Firearm), a class 5 felony

ALEXIS MARY FERNANDEZ, AKA: "LUCKY", 19, of Westminster

- Attempted Murder 1st degree (Accessory to Crime class 1 or 2
- · Felony), a class 2 felony
- · Tampering With Physical Evidence, a class 6 felony

The defendants are being held in the Adams County Detention Facility pending further court proceedings.

The Adams County Sheriff's Office or North Metro Drug Task Force has determined that there is probable cause to make an arrest. The defendant(s) are presumed innocent until convicted in court. The 17th Judicial District (District Attorney) may decline to prosecute or refuse to file charges in this proceeding. Consequently, charges are often reduced, dropped or dismissed.
