## **Blue Envelope Program Adopted in Adams County**

Adams County, Colo. (May 23, 2025):

The Adams County Sheriff's Office is proud to announce a partnership with the Thornton Police Department and the Thornton Fire Department for the official adoption of the Blue Envelope Program. The Blue Envelope Program is a community-focused initiative designed to improve interactions between first responders and drivers with autism and other neurodiverse conditions. It launches on May 23, 2025, and aims to promote understanding, reduce stress, and foster safer communication during contacts.

The Blue Envelope is a tool that community members can use to notify law enforcement and fire rescue personnel that they may need additional time or accommodations during a contact or incident. Inside the envelope is information for both the person contacted and law enforcement or fire rescue personnel, providing guidance and promoting a calm, informed interaction.

# Blue Envelope Program

## Tips for First Responders: (Officers, Firefighter, EMT, etc)

- The driver may exhibit signs of anxiety due to bright lights and noises (your radio/siren).
- Driver may display repetitive body movements or fidgeting and may have unusual eye contact.
- Speak clearly, use the most simplistic explanations possible, and limit unnecessary details.
- Allow the driver extra time to respond.
- Clearly tell the driver when the stop is over, and they can leave.
- If the driver becomes upset, consider contacting the person listed on the contact card inside the envelope.

## Tips for Interacting with Police:

### Do:

- Take a deep breath and listen to questions and directions.
- Tell the officer you have a blue envelope and provide it when asked.
- Keep hands visible to the officer.

### Don't:

- Reach for things without permission.
- Leave without permission.
